ELIGIBILITY: Open to any artist, professional or amateur, 18 years of age or older, from within a 150 mile radius of Danville. (An artist entering this show may not enter the same works entered in the Town & Country Exhibit.)

MEDIA CATEGORIES: Entry is non-juried, with competition in the following categories:

1. Oil/Acrylic Painting
2. Watermedia
3. Drawing, B&W and Color
4. Digital Media/Photography
5. Mixed Media and Other (No crafts)
6. Sculpture/Ceramics

AWARDS: Best of Show: **\$150**
1st prize in each category: **\$100**
2nd prize in each category: **\$50**
3rd prize in each category: **\$25**



This show is partially funded by a grant from the John P. Cadle Foundation.

- The Danville Art League reserves the right to limit prizes in any category due to insufficient participation and the judges discretion.
- **FEES AND ENTRY PROCEDURES:** The entry fee of \$25.00 for non-members or \$20.00 for Danville Art League members with the entry form for a maximum of three (3) entries is due Saturday, April 27, 2019. Up to 3 additional works may be entered in a different category for \$10 each. No more than 3 works may be added in any one category.
- Make all checks payable to Danville Art League. In the memo please include: for entry in Open Show.
- ALL WORK IS TO BE HAND DELIVERED TO THE DANVILLE ART LEAGUE ON SATURDAY, APRIL 27, 2019 BETWEEN 9AM AND 2PM.
- When checking in, notify us if someone else will be picking up your work.
- Each piece is to be labeled by a 3x5 card attached to the back with the following information:
 - Artist's Name, Address, Phone Number
 - Media Category, Title of Artwork
 - Price, SA or NFS
- The Art League will accept a donation of 15% from the sale of an artist's work during this exhibition. Sales of any works and the collection of applicable taxes are the responsibility of the individual artist.
- Two-dimensional work must be ready for hanging, including the wire. Sawtooth hangers cannot be accepted. **ANY WORK NOT CORRECTLY LABELED AND READY TO HANG CANNOT BE ACCEPTED.**
- Entries must not have been entered in any Sharon Schmitz Regional Open Art Competition or Town & Country Amateur Art Show previously.
- Due to the public nature of this show, the Danville Art League reserves the right to make final judgment on the display of any work.
- The judge will offer a critique for artists on Saturday, May 11 at 1:00 p.m. An artist reception for artists and their guests will be held Saturday, May 11 following the critique. Refreshments will be served.
- The exhibit will be open Tuesday – Saturday, 9 a.m. to noon April 30 - May 31.
- **Entries must remain until Saturday, June 1, 2019.** Entries must be picked up on Saturday, June 1 from 9 a.m. to 2 p.m.
- All reasonable effort will be made to protect each work exhibited; however, the Danville Art League is not responsible for loss or damage to entries.
